Content Creation: Create honest and accurate content regarding CAKE.com's products. Avoid making false claims and adhere to advertising standards. Refer to our <u>Content Marketing Policy</u> for additional guidance.

Social Media Compliance: When promoting CAKE.com's products on social media, strictly follow the platform's rules. Refer to CAKE.com's <u>Brand Guidelines</u> and <u>Social Media</u> <u>Marketing Policy</u> to maintain brand consistency. Always disclose your affiliate relationship in your posts.

Earnings and Payments

Commission Structure: You will earn a 30% commission on sales made through your affiliate link, recurring for up to 12 months for monthly plans. Be transparent about your earnings and comply with financial regulations applicable in your country.

Payout Method: Payments are made exclusively via bank transfer; therefore, it is crucial to provide accurate bank information for seamless payouts.

Tax Regulations: Payments will be issued from two entities based on your residence. If registered, please submit all necessary tax documents, such as W8, W9, and W8 BEN-E Forms.

Payment Details: To avoid chargebacks, the first payments will be made 62 days after the end of the month in which transactions occur, with a minimum payout threshold of \$100.

Prohibited Practices

Avoid Misleading Practices: Do not engage in false advertising, spam, or deceptive tactics such as cookie stuffing. Adhere to all laws against false advertising.

Search Engine Advertising: Comply with <u>CAKE.com's PPC Policy</u>. Do not use CAKE.com's branded keywords or trademarks in PPC campaigns, and ensure compliance with intellectual property laws.

Tracking and Links

Accurate Tracking: Use your affiliate link correctly to track sales. Do not alter or disguise your link, and ensure compliance with tracking and data protection regulations.

Refunds and Adjustments

Handling Refunds: In case of a refund, commissions will be adjusted accordingly. Please refer to our <u>Refund Policy</u> to understand how this affects your earnings.
